### Gary Mollenkopf

Cue Bids in Competitive Auctions

Bidding gets more complicated when the opponents open the bidding and your side makes an overcall, or when you or your partner opens and they overcall. Cue-bidding the opponents' suit (or suits) can clarify certain hands that your side has. Gary will offer tips for making the most of this part of your bridge bidding toolkit. Gary Mollenkopf taught music in public schools for many years, and now is a beloved teacher for beginning and intermediate bridge students. You may have seen him playing the guitar or singing in some of our bridge musicals written and directed by Joel Hoersch).

### Joel Hoersch

Adventures & Misadventures: Tales from the Trenches

Joel has seen many interesting, challenging, embarrassing, and ego-enhancing bridge hands and challenges over the years. He will share some of the best – and worst – with you.

Joel Hoersch played his first hand of bridge his first year of college, and his first ACBL tourney a year later. He played in his first national tourney at the Hotel Del Coronado in 1959, came in 1st in section in the novice event, and amassed a sumptuous total of 11 masterpoints. In the five decades since then, he has been involved with the sport of bridge in many different ways, mostly as a player, teacher and writer. Also, he has performed onstage at bridge entertainments since 1970, when he collaborated in writing a Western spoof entitled "Dirty Deal at Goren Gulch."

**Kitty Cooper**  
Bridge Tips

**K**itty is a bridge expert who is also well-known genetic genealogist. She blogs and presents about DNA testing regularly. Kitty used to teach bridge classes in NYC and has founded and been involved with several Bridge in the Schools programs. She wrote the manual on teaching Bridge to children for the ACBL. With her husband Steve, she travels in their RV to many bridge tournaments. Kitty and Steve are both Grand Life Masters having won two National Championships together plus finished high in several others. Kitty has six other National wins, plus the Venice Cup, a World Championship, and the Common Market Mixed Teams Championship. Kitty and Steve usually make the top 200 of the Barry Crane 500. Kitty notes: "We have learned much from each other, aside from the difficulty of playing with one's spouse. He has improved my defense and I have improved his bidding."

**Robert Todd**  
Hand Evaluation

**H**igh card points are not the only way to evaluate the worth of a bridge hand. Distribution, spot cards, supporting honors, and more can affect the quality of a hand. Certain holdings can improve – and others can get worse – as the bidding progresses. Robert will give you a good grounding on principles to help you make the best decisions regarding the value of your hand. Robert Todd is a professional bridge player and teacher whose hometown is Tallahassee, Florida, but you will find him all over the country playing and teaching bridge. Robert began playing bridge at a very young age and came to duplicate while working on his graduate degree in Mathematics. He spent a year in Helsinki, Finland, where he met and played with many fine European players. Robert has finished in the top 20 on the Barry Crane list (with over 1500 masterpoints).

Negative Inferences

**N**egative inferences involve noticing what was not bid and what was not led. What does not happen at the bridge table is often as important as what does happen! Paul will lead you through some of the important negative inferences that arise when you play bridge. Gain some great illumination and chances to sharpen your skills at visualizing bridge hands and plan your own bidding, play, and defense more accurately. Paul is a bridge professional and teacher in the Solana Beach and Rancho Santa Fe area. (He is also a fabulous opera singer.) He was co-founder of a bridge club in Solana Beach and is active on the tournament circuit, winner of many regional and other titles. He loves to teach and to keep things simple.

Bridge Infections and What You can do to Cure Them

Bridge players are often overcome with infections such as High Card Pointitis, Conventioitis, and Ruleitis. David will discuss the origins of these infections, and how you can inoculate yourself so that they will not damage your game. David Abelow has been playing bridge since high school. He is a Diamond Life Master with more than 7500 points. In 2007 he won the national NAOP Open Flight – along with that national win, he hopes to make it to 10,000 MPs someday to become a Grand Life Master. David has been the bridge instructor on six cruises, and currently works with students in the San Diego area.
