"Reverses"

Reverses are misused more often than almost any other bid. Even experts go astray in auctions involving reverses. Hamish will shed light on this challenging topic and offer tips to improve our accuracy in bidding.

Hamish Bennett started to play bridge at nine years old. He played in college and was captain of the Oxford University bridge team in 1955 against Cambridge. Hamish came to the US in 1959 and played bridge sparingly during his working career. Since he retired, bridge has become a passion.

Although he has over 23,000 masterpoints, he does not consider himself a pro, but perhaps an "accomplished" amateur.

Scott Campbell

"Listen & Learn from the Auction"

Scott is a full-time ACBL tournament director, a club manager, accredited bridge teacher, and Gold Life Master. Scott will help you to gather the clues that occur in a bridge auction. Like a detective, you make deductions and put together a picture of the other hands at the table. You learn how to calculate what cards your partner is apt to hold, and how you can best defend each hand.

A popular presenter, Scott runs the 299er programs, including daily lessons, for the four District 21 Regionals in north central California. He also earned the Fred Friendly award in 2009 (as a director) and is a member of the National Charity Committee and ACBL Goodwill Committee. While working for Bank of America 25 years, he traveled all over South and Central America, Africa and Asia, meeting his wife (Rocio) in Colombia.
